# Open Enrollment 2024 Ends Friday. Enroll Today!

Open enrollment ends this Friday, November 17 at midnight. Don't miss your chance to make the benefits choices that are right for you and your family.

We encourage you to review your benefits during open enrollment; however, you do not need to act unless you want to make a change to your current benefits or contribute to a health care flexible spending account (FSA) or dependent care spending account (DCSA).

An important word about enrolling – While you have until Friday at midnight to finalize your benefits elections for next year, the Office of Employee Benefits will be closing Friday at 4 p.m. After that time, we will not be available to assist you. For that

reason, we ask that you do not wait until the last minute to enroll. If you do not complete your 2024 benefits enrollment by end of day Friday, you will not be able to make any changes until next year's open enrollment (unless you have a qualifying status change).

# Don't Delay. Elect Your 2024 Benefits Before It's Too Late.

Visit the **Workterra enrollment site** to:

- Enroll in, make changes to, or drop medical, dental, vision, life insurance, and/or legal coverages.
- Waive medical coverage and elect the opt-out payment.
- Add or drop dependents from your medical, dental, and vision coverage.
- Enroll in a health care flexible spending account (FSA) or dependent care spending account (DCSA). If you want to have an FSA or DCSA in 2024, you must enroll during the open enrollment period.

Enrolling with <u>Workterra</u> online is intuitive and convenient. However, we know that sometimes you need a little extra help. Download the <u>Workterra User Guide</u> for detailed instructions on using the system to complete your enrollment. If you can't log in to Workterra or need help resetting your password, call the BCBSRI State of Rhode Island Employee CARE Center at 401-

429-2104 or 866-987-3705. CARE Center hours are Monday—Friday, 8 a.m. to 8 p.m., and Saturday, 8 a.m. to 12 p.m.
